Whereas, Electricity Law No. (1) of the year 2009, the Ministry has been granted the right to allow the private sector to participate in generating electrical energy under the build-operate-transfer system (BOT).

And based on the interest of the political leadership in the electricity sector and its projects, and giving them priority and care in light of the urgent need to provide electricity in particular due to the blockade imposed on Yemen. In addition to the importance of energy projects in the field of development and in order to improve the investment climate through energy generation via partnership between the Ministry and the private sector in this vital sector.

Within the framework of the national vision for building the modern Yemeni state and in implementation of what was included in the strategic plans of the Ministry of Electricity and Energy regarding infrastructure projects in the field of various electricity activities, including enhancing power generation through the investor's complete financing (100%) through the build-operate-transfer (BOT) system with the aim of providing electrical energy at the lowest possible cost.

The Ministry of Electricity and Energy is seeking to implement the provisions of Articles (5,4) of Electricity Law No. (1) of 2009 through this announcement to the following:

1. To provide the Ministry's needs of electrical energy that meet the current and future demand of energy.
2. Encouraging the private sector to participate in electricity infrastructure projects **due to** its positive impact on the national economy, through attracting local and foreign capital and transfer of technology and knowledge in a way that enhance the efficiency of employees and raises the level and quality of service provided.
3. Benefit from the expertise of the private sector regarding construction efficiency and management, operation and maintenance of electric power generation plants.
4. Seeking to achieve a competition and enhancing the transparency of procedures with the aim of reducing the cost of the final product to the consumer.

In accordance with the decision of the Electricity Regulatory Council No. (11) of 1445 AH (*Subject Five*) approving the expression of interest request document for the participation of local and foreign investors in financing and implementing of electric power generation projects using the BOT system.
